Our History

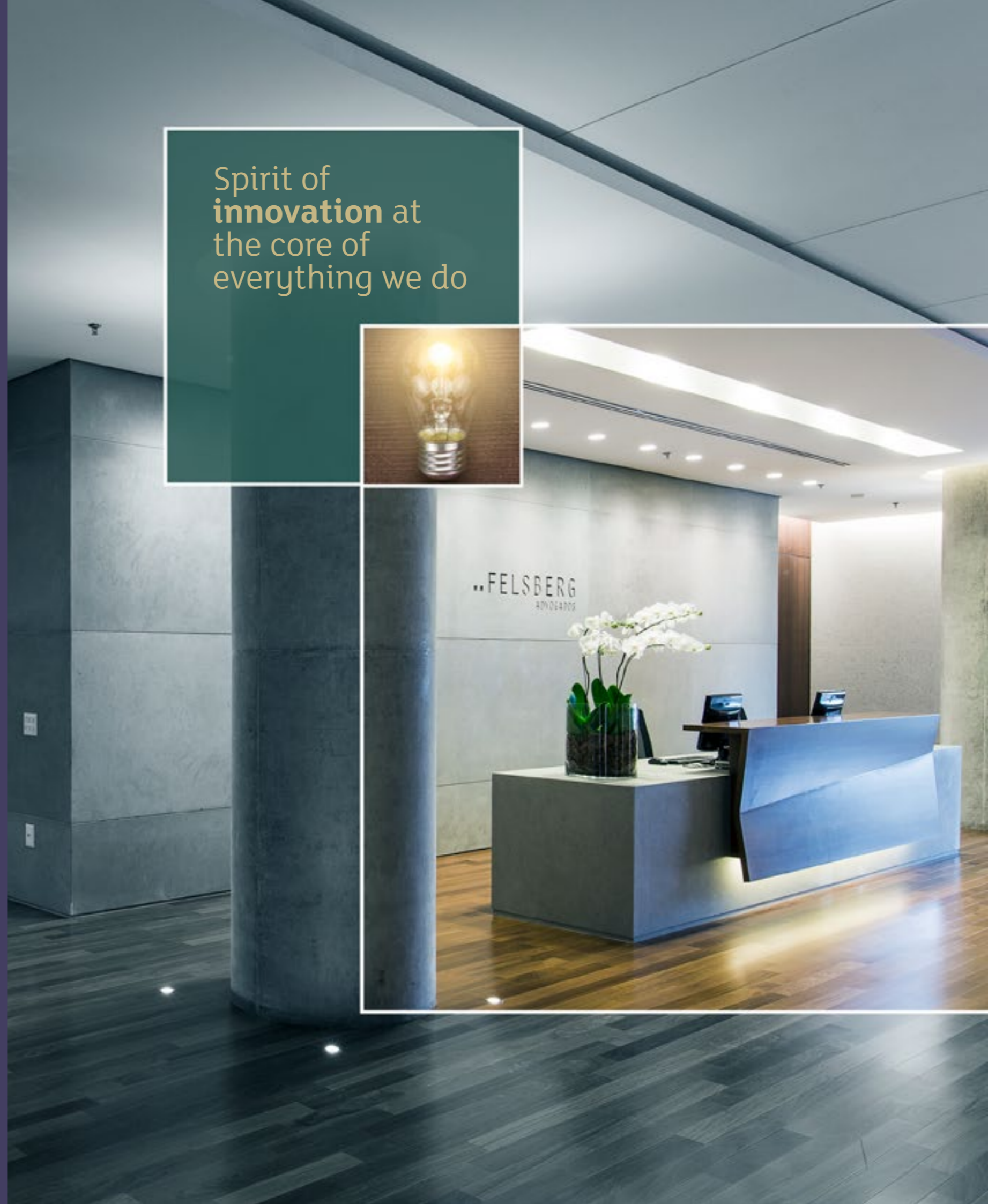
Founded by Thomas Felsberg, the firm has always had an innovative spirit at the core of everything it does.

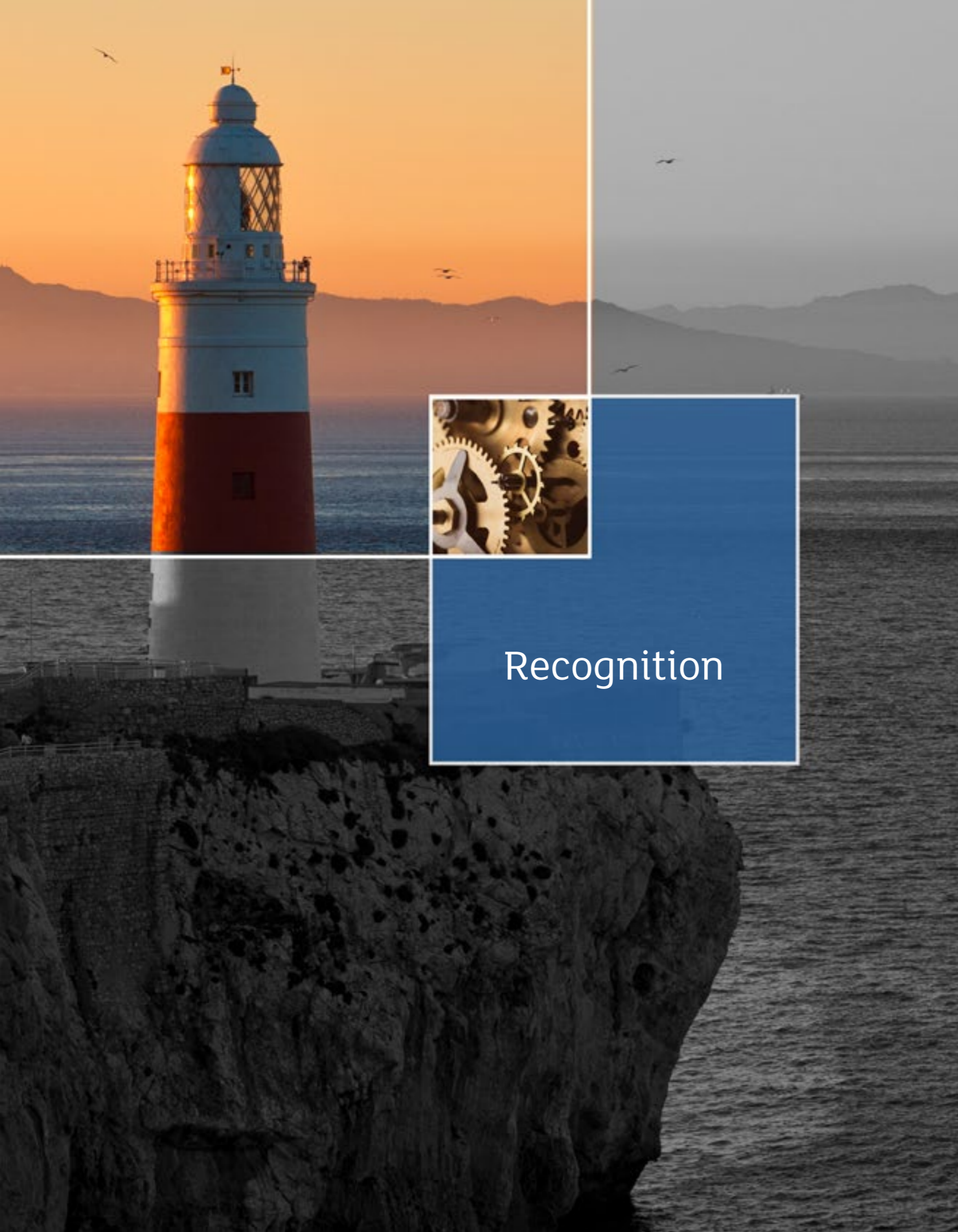

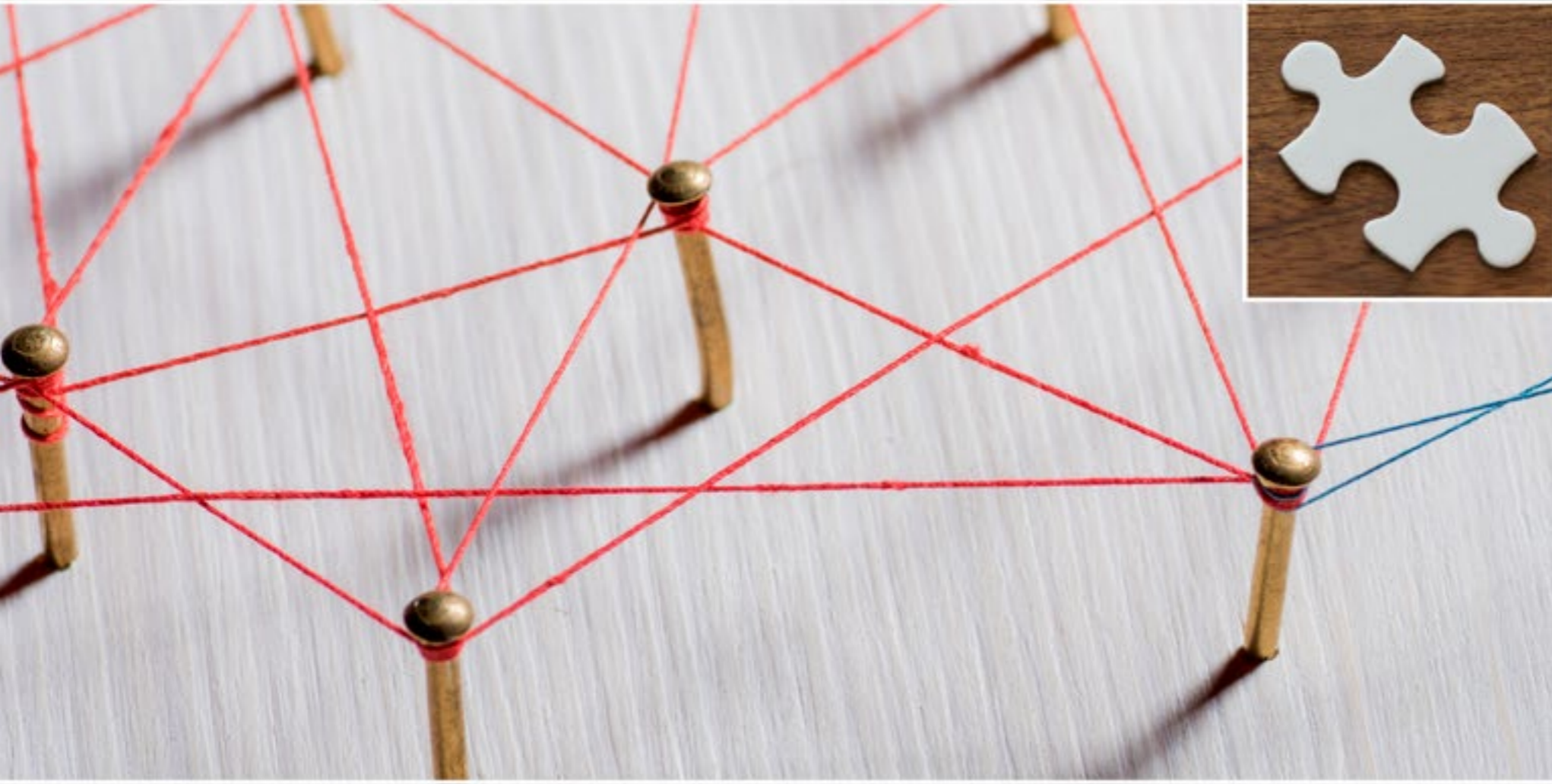
