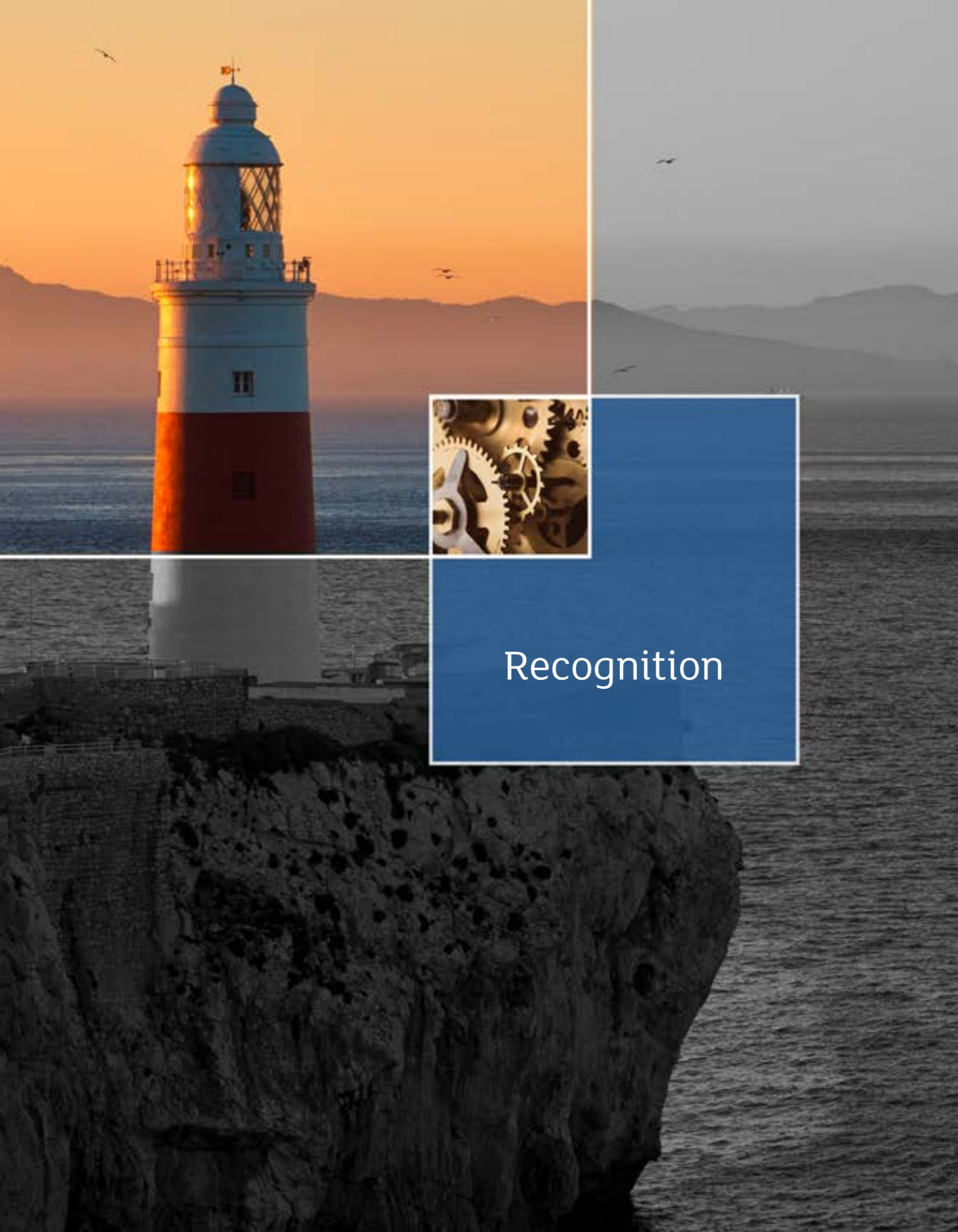

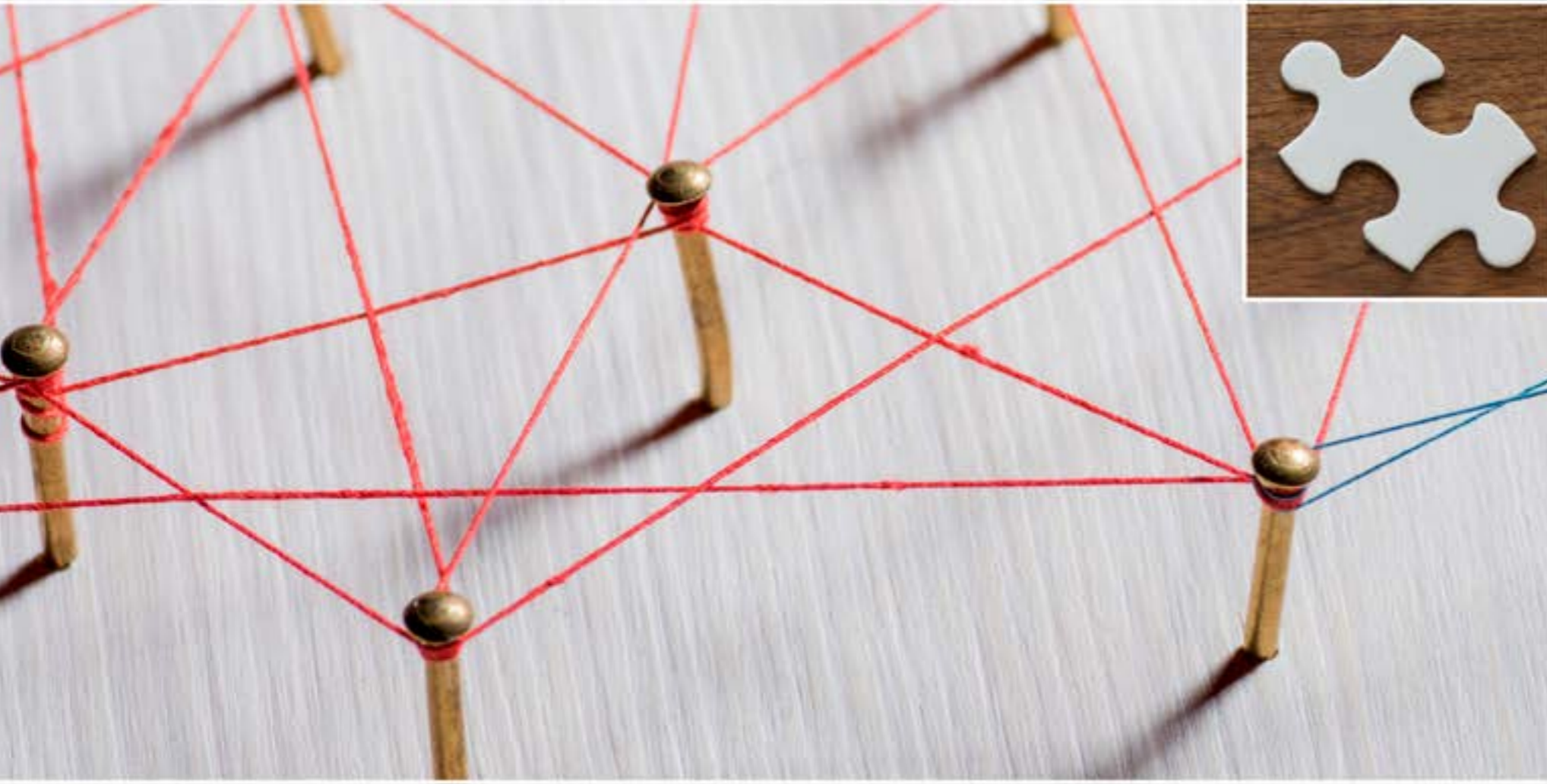
Real Estate

Our real estate team has vast experience in preparing and negotiating all types of real estate agreements, including purchase, sale, leaseback, exchange, donation, lease, rural lease, built-to-suit lease, real estate partnerships, subdivision of lots, and creation of surface rights, as well as acquisition of real estate through corporate acts or extrajudicial auctions and agreements related to commercial, industrial, or residential real estate.

We advise developers and construction companies on issues ranging from financings and provision of in rem guarantees within the scope of the Housing Financial System (SFH) and the Real Estate Financing System (SFI) to the development of projects on rural properties and on rectification of such properties before the Real Estate Registry Offices, the National Institute of Colonization and Agrarian Reform (INCRA) and the Federal Revenue.

We also advise on the creation of real estate investment funds and private equity funds, as well as the distribution of quotas of these funds, both public and restricted placement.
